

PRIVACY POLICY



*Before opening the Account and use the Services in accordance Terms of Use, we advise clients to carefully read this Privacy Policy. If the user does not agree with this Privacy Policy, then the user should refrain from using the Services or opening the Account.

1. INTRODUCTION

- 1.1. The purpose of this Privacy Policy is to describe how and why DEALNOX LLC (here and after "we," "our" or "us") collects and processes personal information about you, how this information is protected, and your rights in relation to it. Personal information is information, or a combination of pieces of information, that could reasonably allow you to be identified.
- 1.2. DEALNOX LLC only collects the information which is necessary and will not share the client's personal information with any third parties unless it is necessary. Even within DEALNOX LLC, access to clients' personal information is limited to only those employees who require such information to handle matters relating to compliance, identity verification, fraud prevention, and customer support.
- 1.3. The following Privacy Policy shall apply to the use of DEALNOX LLC services specifically, DEALNOX LLC Website https://dealnox.com/, or any analog, derivative, or variation thereof (together with any related thereto, individually and/or collectively, as the context may require, the "Website")

2. **DEFINITIONS**

- 2.1. Privacy Policy this Privacy Policy was created and issued by DEALNOX LLC;
- 2.2. User an individual who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data or an online identifier, or one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of the individual, which has opened the website;
- 2.3. Personal data any information relating to an identified or identifiable natural person; an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person. DEALNOX LLC does not consider personal data to include information that has been anonymized;



3. PERSONAL DATA WE COLLECT

- 3.1. DEALNOX LLC collects personal information when you register with DEALNOX LLC when you use our products or services when you visit website pages or the pages of certain our partners. We may combine information about you that we have with information we obtain from business partners or other companies.
- 3.2. When you register we ask for information such as your name, email address, address, city, country, etc. Once you register with DEALNOX LLC and sign in to our services, you are not anonymous to us.
- 3.3. We collect information about your transactions with us and with some of our business partners, including information about your use of products and services that we offer.
- 3.4. We automatically receive and records information on our server logs. This information is used to provide statistical data about our users' browsing actions and patterns, and does not personally identify individuals. This information may include:
- a) log Information: the type of browser you use, access times, pages viewed, your IP address, and the page you visited before navigating to our Services;
- b) device information: information about the computer or mobile device you use to access our Services, including the hardware model, operating system and version, unique device identifiers, and mobile network information.
- c) exchange information: information about the exchange transactions you complete on the website, including the amount of virtual currency associated with an exchange transaction, the types of exchanges executed, and other transaction information
- 3.5. DEALNOX LLC uses the information for the following general purposes: to customize the advertising and content you see, fulfill your requests for products and services, improve our services, contact you, conduct research, and provide anonymous reporting for internal and external clients.

4. HOW WE USE PERSONAL DATA

- 4.1. We will typically only process personal information under the following circumstances:
- 4.1.1. the processing is necessary to perform a contract with you (or your employer/ company) or take steps to enter into a contract at your request, such as to negotiate a contract with us, to fill an order, or to provide product information that you have requested;
- 4.1.2. the processing is necessary for us to comply with a relevant legal



obligation, such as keeping accounting records;

- 4.1.3. the processing is in our legitimate interests, which are not overridden by the interests and rights of the relevant individual whose personal data is collected; or
- 4.1.4. you have consented to the processing.
- 4.2. Where our reason for processing personal information is because it is in our legitimate interests, our purpose for processing it will typically be one of the following:
- 4.2.1. to identify you (or your employer/company) as a prospective customer for products or services and provide you with relevant information about these services and/or invitations to events:
- 4.2.2. to manage our relationship with you by communicating with you (or your employer/company) about or providing to you our services;
- 4.2.3. to carry out our contractual obligations to customers and users of our services and to exercise our rights and obligations under such contracts; to conduct, operate, market, and develop our business activities and improve our services in order to better serve our customers and users;
- 4.2.4. to create aggregate data for informational materials and statistical reports related to our products and services;
- 4.2.5. to improve the quality of our website(s) and tailor them to your preferences;
- 4.2.6. to detect and prevent fraud to ensure the integrity of our markets, including by conducting surveillance of issuers and trading activities and reporting suspected misconduct to applicable regulators and authorities;
- 4.2.7. to comply with our obligations as an operator of Trading Systems (e.g. Regulation Systems Compliance and Integrity);
- 4.2.8. to monitor security threats involving the use of our products, website(s), or other services:
- 4.2.9. to pursue and enforce our legal rights or defend claims or potential claims against us related to our business, products, and services; and/or to implement social networking features you have activated.
- 4.3. When we process personal information to meet our legitimate interests, we put in place robust safeguards to ensure that your privacy is protected and to ensure that our legitimate interests are not overridden by your data privacy interests or fundamental rights and freedoms. If we ask for your consent to process your personal information, you may withdraw your consent at any time by contacting us using the details at the end of this Privacy Policy.



5. DISCLOSURE OF INFORMATION

- 5.1. DEALNOX LLC does not rent, sell, or share personal information about you with other people or non-affiliated companies except to provide products or services you've requested when we have your permission, or under the following circumstances:
- 5.1.1. we provide the information to trusted partners who work on behalf of or with DEALNOX LLC under confidentiality agreements. These companies may use your personal information to help DEALNOX LLC communicate with you about offers from DEALNOX LLC and our marketing partners. However, these companies do not have any independent right to share this information.
- 5.1.2. We may share your personal information with law enforcement, data protection authorities, government officials, and other authorities in the following cases:
- a) If we believe disclosure is in accordance with any law, regulation, or legal procedure;
- b) If we think disclosure is needed to prevent any harm or financial loss;
- c) If disclosure is necessary to report certain illegal activity;
- d) To protect the rights, property or safety of DEALNOX LLC.
- e) If we believe your actions are in violation of this Privacy Policy and/or our Terms of Use and AML policy.
- 5.1.3. We transfer information about you if DEALNOX LLC is acquired by or merged with another company. In this event, we will notify you before information about you is transferred and becomes subject to a different privacy policy.
- 5.1.4. DEALNOX LLC does not provide any personal information to the advertiser when you interact with or view a targeted ad. However, by interacting with or viewing an ad you are consenting to the possibility that the advertiser will make the assumption that you meet the targeting criteria used to display the ad.



6. COOKIES

- 6.1. There is a technology called "cookies," which are small text files that a website transfers to a user's hard disk or browser. Cookies can be used by a website to enable its users to store tailored information from the website. Whenever you interact with our website(s), we automatically receive and record information on our server logs from your browser including your IP address, "cookie" information, and the page you requested. These cookies act as identifiers we transfer to your computer or mobile device that allow us to recognize your browser or mobile device and tell us how and when pages in our website(s) are visited and by how many people. Because cookies are simple text and not "executable," a cookie will not give your computer a virus or other harmful program. We also use Google's Analytics Demographics service to collect data such as age, gender, and interests. This data is used to better understand our audience and ensure more targeted advertising on our website(s). Google opt-out information can be found here.
- 6.2. You may be able to change the preferences on your browser or mobile device to prevent or limit its acceptance of cookies, but this may prevent you from taking advantage of some of our websites' features. Our advertising partners, which may include advertisers, advertising agencies, and ad networks, may also transmit cookies to your computer or device when you view or interact with one of their ads that appear on our website(s). Also, if you click on a link to a third-party website, such a third party may also transmit cookies to you. This Privacy Policy does not cover the use of cookies by any third parties other than third-party advertiser(s), as described below.

7. MARKETING

- 7.1. We may communicate company news, promotions, and information relating to our products and services provided by DEALNOX LLC. We may share Personal Data with third parties to help us with our marketing and promotional projects or sending marketing communications. By using DEALNOX LLC, you accept this Privacy Policy and you agree to receive such marketing communications.

- 7.3. For product-related communications, such as policy/terms updates and operational notifications, you will not be able to opt-out of receiving such information.

8.1. We keep personal data only for as long as required to fulfill the purposes for which it was collected (for example, to maintain an accurate record of customer



dealings), subject to applicable legal, tax, or accounting document retention requirements.

8.2. We take reasonable technical, administrative, and physical security measures to protect your information, including applying generally accepted industry standards to protect the sensitive and/or personally identifiable information submitted to us during transmission and once we receive it. Despite these protections, however, we cannot guarantee that your data will be 100% secure. You should take measures to protect your personal information.
